## Treasurer Report: Mark McSweeney

- The ACHA total current assets are \$56,711.
- Estimated 2022 finish cash balance is \$55,998.

- A holiday decorating contest was discussed similar to last year. \$225 was proposed with five gift cards of 100, 50, 25, 25, 25. Mark motioned to approve, Lisa seconded. Motion passed unanimously.
